Å. INTRODUCTION AND AFFIANT EXPERIENCE

JOHN BARRET ROBERT STELTER, being first duly sworn on oath, deposes and says that court

1. I am an Investigator in the Milwaukee County District Attorney's Office. I submit this Affidavit to assist the John Doe judge in the above-captioned proceeding.

2. I have 26 years of experience as a law enforcement officer. I have held the rank of Detective and Lieutenant of Detectives within the City of Milwaukee Police Department. For two years, I worked at the Milwaukee High Intensity Drug Trafficking Area Task Force, (hereafter HIDTA), a state/federal task force with law enforcement officers from the City of Milwaukee Police Department, Federal Bureau of Investigation, Drug Enforcement Administration, West Allis Police Department, Wisconsin Department of Justice, Wisconsin State Patrol, and other jurisdictions. That experience included the investigation of and supervision of the investigation of complex and large scale organized crime in the Metropolitan Milwaukee, Wisconsin area. Over these last 10 years, I have overseen multiple investigations, been involved in the supervision of investigations that involved federal court authorized wiretaps of wire and electronic communications as defined in the Federal Code. I also have participated in investigations involving individuals and organized group activity related to the distribution of drugs and controlled substances, and the laundering of drug proceeds and the concealment of assets purchased with drug proceeds.

3. I incorporate by reference the Applications, Affidavits and other papers, as well as those particularly noted within, that have been submitted to the court in these John Doe proceedings, including any matters or testimony referenced in the paragraphs that follow. I base the following affidavit upon personal knowledge; information and belief

based upon statements and information from fellow law enforcement officers and citizen witnesses; review of subpoenaed documents and documents obtained via search warrants; testimony taken during the course of the John Doe proceedings, and other information as described herein believed to be reliable.

4. I have been authorized by a secrecy order to be made aware of these John Doe Proceedings.

I make this Affidavit in Support of a Subpoena for Documents and Search Warrants as described herein pursuant to Wisconsin Stats §§968.135, 968.375, and 968.12 with respect to the individuals and entities for the evidence described below at the locations described below based upon my personal observation, and information from fellow law enforcement officers, and reliable information and belief:

I respectfully request that the court issue a search warrant for the G-mail account for Cindy Archer, and John Hiller as described above for all communications stored in the account; subscriber names, user names, screen names or other identities associated with the account; mailing addresses, residential addresses, business addresses, other e-mail addresses, telephone numbers or other contact or identifying information for this account (in electronic or other form); billing records; information about length of service, types of services or related information; connection logs and records of user activity, and any information related to sent and received communications, including any "chat" or "instant messaging" or related information for said account, and other records identified in said search warrant.
- f. YAHOO EMAIL Search Warrant. I request that a search warrant be issued to Yahoo Inc., Compliance Team, 701 First Avenue, Sunnyvale, California.94089 for the account of Ed Aprahamian at <u>lezk@yahoo.com</u>; the account of Brian Pierick at <u>pierick.brian@att.net</u> for the timeframe of January 1, 2009 to December 31, 2010, for all communications stored in the account including all incoming and outgoing e-mail; subscriber names, user names, screen names or other identities associated with the account; mailing addresses, residential addresses, business addresses, other e-mail addresses, telephone numbers or other contact or identifying information for this account (in electronic or other form); billing records; information about length of service, types of services or related information; connection logs and records of user activity, and any

information related to sent and received communications, including any "chat" or "instant messaging" or related information for said account, and other records identified in said search warrant.

- g. FICHTSERVICES.COM DOMAIN AND MIDAMERICAN BUILDING-SERVICES.COM. I request a search warrant be issued to Ntelos, 719 High St., Portsmouth, VA. 23704 related to the domain Fichtservices.com and the domain Midamericanbuildingservices.com for the timeframe of January 1, 2009 to December 31, 2010, for the following: the email Ed account of Aprahamian (eda@fichtservices.com and webmaster@fichtservices.com) for the domain Fichtservices.I respectfully request that the court issue a search warrant for all communications stored in the account; subscriber names, user names, screen names or other identities associated with the account; mailing addresses, residential addresses, business addresses, other e-mail addresses, telephone numbers or other contact or identifying information for this account (in electronic or other form); billing records; information about length of service, types of services or related information; connection logs and records of user activity, and any information related to sent and received communications, including any "chat" or "instant messaging" or related information for said account, and other records identified in said search warrant.
- h. SPRINT / AT&T / U.S. CELLULAR, NEXTEL, Et. Al. telecommunication service providers. I respectfully request that the telecommunication service providers listed herein in ¶55 to provide the records with respect to service provided to the cellular and other telephones identified in ¶31 for the respective timeframes - copies of records related to the phone numbers listed including but not limited to 1) billing name and information, subscriber name and information including any application for service; 2) subscriber and/or billing address 3) records of calls to and from said number(s), including incoming and outgoing and local and long distance records for said number(s) for the timeframes



identified below; 4) Length of service, including start date and types of service utilized; 5) Telephone or instrument number or other subscriber number or identity, including any temporarily assigned network address; 6) means and source of payment for the electronic communication service or remote computing service, including any credit card or bank information; for the phones identified in ¶31.

6. The previous affidavits and applications for process establish that employees of the office of the Milwaukee County Executive, such as Tim Russell, Thomas Nardelli, Kelly Rindfleish, Darlene Wink, Fran McLaughlin were involved in political activity during hours while employees of Milwaukee County. Additionally said affidavits and applications establish that Keith Gilkes, Jill Bader, Joe Fadness, Brett Davis, and Cullen Werwie utilized employees of Milwaukee County during work hours for political purposes. Records related to telephone contact and communications between said individuals will provide evidence related to Solicitation involving Public Officials and Employees (PTAC) in violation of Wis. Stats.§§11.36(2), 11.61, and 939.05.

7. I request that the court issue a subpoena for documents and/or a search warrant for the production of the documents and records identified in ¶5 above, said materials providing evidence relating to violations of sections Wisconsin Statutes §§946.12, 19.58, 19.59, 11.36(2), 11.61, 939.30, and 939.05 the Wisconsin Statutes, viz., Solicitation to Commit Misconduct in Public Office, Misconduct in Public Office (PTAC), Solicitation involving Public Officials and Employees (PTAC), and Ethics violations (PTAC).

8. Based upon information and belief, John Hiller resides at at 8949 N. Greenvale Rd., Village of Bayside, Milwaukee County, Wisconsin; Jim Villa resides at 1331 S. 93<sup>rd</sup> St., West Allis, Milwaukee County, Wisconsin; and Cindy Archer resided in Milwaukee County during the timeframe of 2009-2010 when the alleged crimes were committed. The court has jurisdiction over the above offenses pursuant to Wisconsin Stats. §978.05(1) that provides in pertinent part that the District Attorney of the prosecutorial district has the authority to prosecute all criminal violations that occur within that prosecutorial unit, as well as "all criminal actions arising from violations of chs. 5 to 12, subch. III of ch. 13, or subch. III of ch. 19 and from violations of other laws arising from

or in relation to the official functions of the subject of the investigation or any matter that involves elections, ethics, or lobbying regulation under chs. 5 to 12, subch. III of ch. 13, or subch. III of ch. 19, that are alleged to be committed by a resident of his or her prosecutorial unit . . ." In the present case potential criminal charges arising out of violations of Chapter 19 by John Hiller, Jim Villa and Cindy Archer, residents of Milwaukee County as described in the paragraph above, would provide the prosecutor and courts of Milwaukee County with jurisdiction over the above individuals.

9. I use the terms "records" "documents" and "information" to include all items of evidence in whatever form and by whatever means they may have been created or stored, including any form of computer or electronic storage (such as hard disks, jump drives, thumb drives, CDs, DVDs, external USB drives, 3.5" disks or other media that can store data); any handmade form (such as writing, drawing, painting); any mechanical form (such as printing or typing); and any photographic form (such as microfilm, microfiche, prints, slides, negatives, videotapes, motion pictures, photocopies), consistent with Wisconsin Stats sec. 968.13(2).

10. <u>I request that the court authorize Investigators of the Dane County District</u> <u>Attorney's Office, and the Federal Bureau of Investigation's (FBI) to participate in the</u> <u>execution of the proposed search warrants. Chief Investigator David Budde has</u> <u>spoken with Supervisory Special Agent George Strong and Special Agent Sue Blish of</u> <u>the FBI, who indicated to me that the FBI is both willing and able to assist in the</u> <u>execution of the proposed search warrants. I respectfully submit that the FBI will be</u> <u>able to render material assistance to the investigation so as to further legitimate law</u> <u>enforcement purposes.</u>

11. I further request that DA Information Technology Manager James Krueger be authorized to accompany the Milwaukee County District Attorney Investigators on Search Warrants that the court may authorize in connection with this application. He, too, in my judgment will assist law enforcement in the identification of important evidence to be gained as a result of these searches. I request that the warrants extend to all desktop computers, laptop computers, and tablet computers found on the premises.

12. I anticipate that computer equipment and peripheral devices will be seized during the execution of these warrants. I request that the court authorize a forensic examination of such computer equipment and peripheral devices that may be seized, such as forensic examinations described by District Attorney Information Technology Manager James Krueger in his Affidavits dated June 28, 2010 and July 1, 2010. I also refer the Court to the Affidavit of Brad Montgomery dated June 24, 2010, especially its contents under the heading of Computers & Electronic Storage beginning at ¶7. I note that these Affidavits submitted by these Information Technology professionals support the proposition that relevant information may be found on a computer for extended periods of time after data is originally created, even to a point in time after the user believes that such data has been "deleted." I also note that this investigation has been successful in recovering e-mail messages, even though the user had deleted these email messages, as for example when FBI Special Agent Matt Petersen and IT Manager James Krueger recovered thousands of e-mails sent or received and then deleted on the Exchange Server account of tom.nardelli@paratechambulance.com, as well as the recovery of documents on the electronic communication device of John Hiller.

### D. INFORMATION IN SUPPORT OF PROBABLE CAUSE

13. In particular, this affidavit incorporates other affidavits, including the affidavits of Chlef Investigator David Budde dated February 28, 2011, with respect to the application for a search warrant at the address of 10500 North Port Washington Road Suite 203, Mequon, Wisconsin, the offices of John Hiller, John Hiller Realty and J.M. Hiller Consulting, particularly ¶6 to ¶45 of the affidavit including the referenced attachments. I also incorporate by reference the February 28, 2011 the affidavit in support of a subpoena for documents for the Boerke Company, including referenced attachments, with corrections as noted<sup>1</sup>; and finally the affidavit of Robert Stelter dated July 11, 2011.

14. With respect to the duties and responsibilities of the office of the County Executive, Wisconsin Statutes sec. 59.17(2) provides: "Duties and powers. The

county executive shall be the chief executive officer of the county. The county executive shall take care that every county ordinance and state or federal law is observed, enforced and administered within his or her county if the ordinance or law is subject to enforcement by the county executive or any person supervised by the county executive."

EXHIBIT 2

15. Milwaukee County Ordinance §9.05(2)(d) provides: "No disclosure of privileged information: No county public official or employee shall use or disclose privileged information gained in the course of, or by reason of, his / her position or activities which in any way could result in financial gain for himself/ herself or for any other person."

16. With respect to lobbying, Milwaukee County Ordinance Chapter 14 regulates lobbying, and defines a lobbyist as one who is employed and receives economic consideration for attempting to influence or influencing legislative or administrative action by oral or written communication with any county official, and has such lobbying communications on more than 3 days within the reporting period (6 months). In particular §14.03 that provides with respect to registration as follows:

### 14.03. Lobbyist and principal--registration required.

 Any person who acts as a lobbyist, as defined herein, is required to register annually under the provisions of this chapter and shall file, in person, by mail or electronically, on forms prescribed by the ethics board and submitted to the county clerk. Lobbyist registration shall include:

 (a) The full name, occupation, and principal place of employment of the lobbyist or lobbyists;

(b) The identity of the legislative or administrative matter for which the lobbyist has been retained or which the lobbylst supports or opposes;
(c) The name, occupation, and principal place of business of the person, or any other formal or informal group which is directing the lobbying activities and whose interests the lobbyist is representing;
(d) Applicable registration fees.

Principals who employ lobbyists are also required to file a separate authorization for each lobbyist retained by the principal. See §14.03(4).

17. Milwaukee County Ordinance §14.11 provides that a violation of Milwaukee County Ordinance Chapter 14 is subject to a maximum \$1,000 forfeiture.

18. Wisconsin Statutes  $939.05^2$  defines conduct that constitutes party to a crime. The relevant sections appear below. Misconduct in Public Office and Solicitation to Commit Misconduct in Public Office are violations of Wisconsin Statutes §§946.12<sup>3</sup> and 939.30<sup>4</sup> and the relevant sections appear below.

19. Wisconsin Statutes §§11.36(1) and (2) defines conduct with respect to political solicitation of employees and officials and the respective provisions appear

20, Scott Walker was the Milwaukee County Executive from 2002 to 2010. In 2006 and 2010, Walker was a candidate for the office of Governor of the State of Wisconsin. To that end, the "Friends of Scott Walker" campaign committee was established to raise money in seeking that office. According to GAB filings, the committee was comprised of two principals, the candidate Scott Walker and the Treasurer John Hiller. The Friends of Scott Walker also had a campaign "Finance Committee" whose responsibility was raising significant campaign money for the Scott Walker for Governor campaign. Daniel Morse and Mary Stitt were heavily involved in fundraising. The responsibility of the "Finance Committee" was raising contributions from "large donors" (individuals who contributed more than \$2,500 to the campaign). The Finance Committee had a goal of raising \$1,150,000 dollars for the Walker gubernatorial campaign in 2010. Daniel Morse was involved in sending out letters to individuals who agreed to serve on the committee. Those members included Ed Aprahamian and David Boerke, who was involved with the Reuss Plaza lease. (See letters dated July 24, 2008 and August 6, 2008 respectively - Attachment A and B).

### A. REUSS PLAZA

21. The Friends of Scott Walker, according to GAB filings, was comprised of two principals, the candidate Scott Walker and the Treasurer John Hiller. During the Spring of 2010, Scott Walker's campaign Treasurer, John Hiller with the Boerke Company, negotiated for the extension of a lease between Milwaukee County and the Boerke Company at the Reuss Plaza. At that time Andrew Jensen and David Boerke represented "The Boerke Company," a commercial real estate broker, who were also

involved in the lease negotiations on behalf of the building owner. The owner of Reuss Federal Plaza was RAIT Financial Trust. The leased space at Reuss Federal Plaza was space occupied by the offices of the Milwaukee County Department on Aging and the county Care Management Organization. The lease required renewal on or before June 30, 2010 and would expire at the end of 2010 in the absence of extension.

22. John Hiller, as a person involved in the lease renewal negotiations for his client, RAIT Financial Trust, had a direct pecuniary interest in the lease contract. Records obtained from John Hiller per subpoena and search warrant establish that John Hiller through J.M. Hiller Consulting LLC entered into a contract on October 26, 2009 with RAIT Financial Trust for the purpose of assisting RAIT Financial trust in obtaining a lease extension for the Milwaukee County Department of Aging at the Reuss Federal Plaza. Hiller was to be paid a retainer of \$8,500 per month under the contract, with the first payment due with the execution of the contract that occurred on October 30, 2009. Per a review of Hiller bank records, he received minimally a total of \$110,500.

23. Scott Walker, was both a public official and the candidate of the Friends of Scott Walker gubernatorial campaign committee; accordingly he had at least an indirect pecuniary interest in the Boerke lease transaction in that:

- a. During 2009, Boerke Co. representatives contributed \$4,250 to the Friends of Scott Walker, of which \$3,750 came from David Boerke.
- b. Negotiations for "re-upping" (or extending) the lease commenced in late 2009 and continued until June 2010.
- c. Between May 12, 2010 and June 30, 2010, David Boerke contributed an additional \$5,250 to the Walker campaign and Andrew Jensen, also a principal of the Boerke Co., contributed an additional \$350.00. This was during the timeframe in which the Reuss Plaza lease extension was under consideration.
- d. David Boerke, a principal with the Boerke Company, was involved with the Scott Walker for Governor campaign "Finance Committee" whose responsibility was raising significant campaign money for the Scott Walker for Governor campaign. Boerke was responsible for raising contributions from "large donors" (individuals who contributed more than

\$2,500 to the campaign). The Finance Committee had a goal or raising \$1,150,000 dollars for the Walker gubernatorial campaign in 2010.

e. The lease is worth millions of dollars in gross revenues to clients of the Boerke Co. (per an e-mail of Hiller dated 8/23/10, the lease was worth \$853,000 each year - over the 5 year lease term revenues of \$4,265,000 would be generated.)

### MISCONDUCT IN PUBLIC OFFICE (PTAC)

24. I submit that there is probable cause to believe that Scott Walker, John Hiller,
and Andrew Jensen, in concert together, committed a felony, i.e., Misconduct in Public
Office violations of Wisconsin Statutes §§946.12<sup>e</sup> and 939.30<sup>7</sup> in that:

- a. As described above, during 2009 and 2010, John Hiller was the treasurer of the Friends of Scott Walker gubernatorial campaign. During 2009 into 2010, John Hiller, as a consultant and representative of RAIT Financial Trust, together with Andrew Jensen and David Boerke of "The Boerke Company" were involved in negotiations with Milwaukee County with the extension of the lease at Reuss Federal Plaza.
- b. During the negotiations, on or about June 11, 2010, Milwaukee County

Executive Scott Walker directed his Chief of Staff, Thomas Nardelli, to request an extension of the lease of office space occupied by the Milwaukee County Department of Aging at Reuss Federal Plaza. On June 11, 2010, Thomas Nardelli sent an e-mail to Acting Director of Transportation and Public Works Jack Takarian directing him to request the lease extension. The six month lease extension was in the interest of Milwaukee County in order to provide adequate time to evaluate the space needs of Milwaukee County and to consider proposals and plans for any relocation.

- c. On June 14, 2010, Jack Takarian sent an e-mail to Andrew Jensen of the Boerke Company, formally requesting a six month extension of the Reuss Plaza lease.
- d. On Wednesday, June 23, 2010 at 2:58 p.m., County Executive Scott Walker using the private e-mail account, <u>skw@scottwalker.org</u>, sent an e-mail to John Hiller advising that Walker would call Hiller, but instructing Hiller that he (Walker) needs "...a letter to Jack (Takerian) saying *no* to an extension."
- e. On the afternoon of June 23, 2010, Hiller then forwarded the e-mail of County Executive Scott Walker to Andrew Jensen, with a copy to Greg Wolfson (employed by RAIT Financial Trust – the owner of Reuss Federal Plaza). Hiller requested that Jensen draft a letter to Jack declining the six-month extension, with a draft being sent to Hiller. The request from County Executive Scott Walker requesting the *rejection* of Milwaukee County's request for an extension made by Walker's own Department of Transportation and Public Works, was against the interests of Milwaukee County according to witnesses.
- f. John Hiller was involved in drafting the letter rejecting the request for the six-month lease extension.
- g. On June 25, 2010, Andrew Jensen of the Boerke Company sent an email with a letter attached dated June 25, 2010 to Acting Director of

Transportation and Public Works Jack Takarian, rejecting the request for the six-month extension.

Solicitation to Commit Misconduct in Public Office and Misconduct in Public Office.

25. Further, I submit that there is probable cause to believe that John Hiller, in concert with others, solicited county employees to commit a felony, i.e., Misconduct in Public Office violations of Wisconsin Statutes §§946.12 and 939.30 and that Andrew Jensen and county employees were involved in Misconduct in Public Office as Party to a Crime in violation of Wisconsin Statutes §§946.12 and 939.05, including John Hiller, Andrew Jensen, Scott Walker, Tim Russell, Jim Villa, and Cindy Archer in that:

- a. On July 2, 2010, Request for Proposals (RFP) No. 6562 was published in connection with an effort to provide office space for certain county agencies.
- b. The designated county representative for the RFP was Mr. Brian Dranzik, Director of Operations for the Department of Transportation and Public Works.
- c. The purpose of designating a single point of contact, as I understand it, is to assure the fair and equal distribution of all relevant information to all participating vendors.
- d. The pre-approval procedures, including the process of dissemination of information relevant to the RFP, are regulated by county ordinance. (Chapter 32)
- e. On July 27, 2010, rather than contacting the county's designated point of contact, John Hiller e-mailed Kelly Rindfleisch, Deputy Chief of Staff for the Office of the County Executive, asking her to obtain information pertinent to the open RFP process, prior to the close of the submission period for proposals.
- f. On August 12, 2010, after the RFP process closed, but prior to a final decision, John Hiller directly contacted Scott Walker about the RFP via e-mail. In that e-mail to Walker, Hiller proposed three options related to the RFP. One of the options proposed by Hiller asked Walker to accept the "Federal Plaza" bid (that of Boerke Company) as "it won on all merits", with the issuance of a separate RFP that dealt with the City

Campus county property. The RFP contact remained Brian Dranzik.

g. On August 18, 2010, John Hiller directly contacted Scott Walker as a follow-up to the August 12, 2010 e-mail. Hiller suggests that he could get someone, an attorney, to call Corporation Counsel to suggest that they "scrap" the RFP and start over. Hiller suggests the use of "David Halbrooks" so there would be no connection to Hiller.

....

- h. On August 21, 2010 Cindy Archer (using the non-Milwaukee County email of carcher1@wi.rr.com) sends two e-mails. The first e-mail is sent to Jim Villa, Tim Russell and Scott Walker regarding the City Campus analysis related to the RFP. Villa forwards that e-mail to Hiller, with the advice that Hiller is not to respond or discuss as Villa is sharing the information confidentially. Approximately 1 hour later, Archer sends a second e-mail to Tim Russell with a copy to Scott Walker. In the e-mail, Archer proposes that Hiller should propose buying it (the City Campus building that is the subject of the RFP) for \$1. Archer discusses the proposal of Hiller (Boerke Co.) and the different rental rates proposed. In that e-mail, Archer states, "If you can help Hiller, now is the time." In the same paragraph, Archer acknowledges that the other vendors have been told to come back with a best and final offer by Wednesday (August 25). On August 22, 2010 at 11:14 a.m., Archer forwards the email regarding the Reuss Federal Plaza to Jim Villa at iv@jimvilla.com; Villa in turn forwards the e-mail of Archer to Hiller on that date at 11:38 a.m., with the message, "Again, confidential."
- i. On Monday, August 23, 2010 at 12:35 p.m., Archer (using her private email <u>carcher1@wi.rr.com</u>) sends Hiller an e-mail, with a copy to Scott Walker and Villa, discussing the costs and the RFP. Also attached is a document related to the City Campus / RFP proposal and an analysis of the costs and levy impact.

26. I incorporate by reference and attachment the affidavit of Robert Stelter and exhibits dated September 7, 2011 with respect to a search warrant application for the Boerke Company, as it relates to the lease negotiations and RFP related to Reuss Plaza.

27. As detailed above, John Hiller - the campaign treasurer for the Friends of Scott Walker gubernatorial campaign fund, maintained contact directly with members of the Milwaukee County Executive office including Milwaukee County Executive Scott Walker, seeking the extension of the Reuss Plaza lease and response to RFP 6562. John Hiller had a pecuniary interest in a lease with the Boerke Company. At this same time, Scott Walker had a direct or indirect pecuniary Interest in a contract with the Boerke Company, created as a result of Hiller's status as campaign treasurer and his involvement in the lease extension and RFP on behalf of the owners of the Reuss Plaza. David Boerke was also a member of the "finance committee" - a committee involved with contributors to the Scott Walker for Governor campaign in amounts greater than \$2,500. Scott Walker also had a direct or indirect pecuniary interest in the contract as a result of campaign contributions from individuals from the Boerke Company.

Cindy Archer, Milwaukee County Director of Adminstrative Services provided information related to Reuss Plaza to Jim Villa, the former Chief of Staff for Scott Walker, who in turn provided the information to John Hiller, a representative of RAIT Financial Trust, the owner of Reuss Federal Plaza, whose proposal was pending with those of other vendors in August, 2010. Also involved was Tim Russell, an employee with the Milwaukee County the Department of Housing. Jim Villa was the former chief of Staff for County Executive Scott Walker from approximately 2002 to 2003 and 2005 to June 2007. Accordingly, based upon the information set forth in this affidavit, I believe that probable cause exists that evidence related to a violations of Wisconsin Statutes §§946.12, 939.30, 19.58 and 19.59 and 939.05 may be found with the person and at the residence of Cindy Archer; I also believe that said evidence may be found with the person, residence and office of Jim Villa, and request that the court issue a search warrant for the above premises for the evidence described in ¶5(a) and ¶5(b) above.

B. PRO

### PROTECTING AMERICA'S FUTURE, WISCONSIN FUTURE FUND, RUNNER MEDIA AND RELATED ACTIVITIES.

28. Timothy Russell, John Hiller and Jim Villa are involved in political action committees, and in the course of that involvement, Russell was engaged in political activity while a Milwaukee County employee. The political action committees include

the Fund for Wisconsin's Future (FWF), the related political action committee (Wisconsin Future Fund –WFF) PAC, and Protecting America's Future (PAF) in Wisconsin. Russell's involvement is documented in the e-mail of Timothy Russell dated February 22, 2010 sent to John Hiller and Jim Villa on the subject of FWF (Fund for Wisconsin's Future), PAC, and Runner Media. Russell describes the incorporation of FWF (Fund for Wisconsin's Future) and the related political action committee (Wisconsin Future Fund –WFF) PAC. With a "board that will be workable for us." Russell indicated that the board consisted of John Schulze, Elia Lemke and Kathy Willis. Russell indicated that only John (Schulze) would speak for the organization. Subsequent e-mail's establish that Villa, Hiller and Russell were involved in political activity related to the above WFF formed in connection with FWF. Many of the contacts and activities occurred with Timothy Russell, who was a Milwaukee County employee during that timeframe.

Ξ,

- a. Mr. Timothy Russell was a Milwaukee County employee during 2010, including the months of April and May 2010. This is based upon a review of Ceridian time card records submitted by Mr. Russell reflecting that on the dates of April 7, 20, 21 and 22, 2010 and May 3, 4 and 5, 2010, Mr. Russell was working. A review of e-mails previously secured through prior process, Russell sent an e-mail to John Hiller and Jim Villa on Tuesday, April 6, 2010 at 8:31PM, with a subject line "Rove on 4/21". The body of the e-mail reads in part; "John any confirmation on the 4/21 mtg?" (Exhibit 1)
- b. On Wednesday, April 7, 2010 at 9:35AM Russell sends an e-mail to John Hiller and Jim Villa that states in part; "Ok, I booked to go out on the 20<sup>th</sup> arriving around 5:30 and returning on the 22<sup>nd</sup> need to be at the airport by 4. Got it on Airtran for 217 including taxes." (Exhibit 2)
- c. Upon a review of an e-mail dated May 2, 2010 at 8:14PM, Russell sent an e-mail to the e-mail address scott.evertz@gmail.com. The subject line is "Tomorrow night". In the body of the e-mail Russell-writes in part; "any chance you're in DC tomorrow night? I'm coming out for a lunch event Tuesday". On Monday, May 3, 2010 at 5:14AM scott.evertz@gmail.com replied; "I've got a commitment tonight so 1

won't be able to meet for a drink. I assume the lunch you're going to is the Walker fundraiser." (Exhibit 3)

- d. On Monday, May 3, 2010 at 8:22AM Russell replies in part; "Actually the trip is to try to catch TGT at the SKW event to corner him for a projects Hiller, Vila and I are working on". Based on the content of the e-mail I know TGT to be Tommy G. Thompson, former Governor of Wisconsin and SKW to be Scott K. Walker the current Governor of Wisconsin and in April and May of 2010 the County Executive of Milwaukee County. (Exhibit 3)
- e. I subsequently reviewed the Guaranty bank statement for Timothy Russell and Brian Pierick account #23237511 which had been obtained through previous process and note a transaction on April 8, 2010 for \$213.90 on Airtranair. On May 3, 2010 there is an additional transaction for \$160 for Airtranair.
- f. Both purchases coincide with the discussions in the e-mails cited above for trips to Washington DC. Based upon the content of the e-mails, neither trip, in the best light appears to be in relation to business related to Russell's position as an employee for Milwaukee County, but rather political activity related to Protecting America's Future (hereafter PAF). Protecting America's Future is a political committee with the purpose of influencing 2010 United States House of Representative and Senate elections. (See Exhibit 4). John Hiller, Jim Villa, and Timothy Russell, among others were involved in organizing the committee (see e-mail of July 11, 2010 – Exhibit 5 and August 4, 2010 – Exhibit 6) Further records from Airtran reflect that Russell did not travel to Washington D,C.
- g. When Russell was involved in political activity on behalf of PAF (Protecting America's Future),with Jim Villa, John Hiller, at times it was during hours that he was a Milwaukee County employee. Related to that political entity, Russell receives a e-mail chain on August 3, 2010 at 3:35 p.m. from John Hiller, when a question is raised about whether Russell had applied for a "EIN" (Employer Identification Number). At 3:41 p.m.

(on August 3), Russell responds to Hiller with a copy to Villa that he did when he originally did the documents for submission prior to an attorney doing it. (Exhibit 7). Russell was working as a county employee on August 3, 2010 based upon a review of Ceridian time card records submitted by Russell.

- h. On August 4, 2010, at 9:50 a.m., Villa sends an e-mail with a copy to Russell, discussing an ad. Villa asks if there was an official name for the entity and "verbiage: to be used for the ad disclaimer. Villa also asks Phil Prange if they have money. John Hiller responds to Villa at 10:28 a.m. with a copy to Villa regarding Protecting America's Future Inc, that he will check with the attorney on the exact language and a review of the ad for compliance. (Exhibit 8)
- I. Russell was also involved in political activity related to FAF and WFF and Runner Media with Jim Villa, and John Hiller. (See Exhibit 9, e-mail of Tim Russell of October 5, 2010, a workday for Russell according to Ceridan records) On August 20, 2010, Tim Russell responds to an email sent by Jim Villa that asks Russell to obtain approval for a script in which Former Governor Tommy Thompson expresses support for Brett Davis and his candidacy for Lt. Governor. (Exhibit 10)
- j. Russell was involved with John Hiller and Jim Villa with Runner Media. Runner Media was involved in the purchase of media time on behalf of political action committees. On February 22, 2010, Russell sends an email regarding WFF and the formation of Runner Media. (Exhibit 11) Russell continues that discussion about the structure "of this venture" on February 23, 2010 at 11:02 a.m. in an e-mail to John Hiller. (Exhibit 12) Russell was working as a county employee on February 23, 2010 based upon a review of Ceridian time card records submitted by Russell. In relation to Runner Media, on March 24, 2010 at 10:57 a.m., Russell sends an e-mail related to the Runner Media in which he states "I am the RA (registered agent), for profit, annual sales 25k, no employees, no cash needs. (Exhibit 13) Russell was working as a county employee on

March 24, 2010 based upon a review of Ceridian time card records submitted by Russell. Runner Media and PAF are the subject of a conference call on June 11, 2010 with Russell, Hiller and Villa. (Exhibit 14).

k. On August 20, 2010 at 10:12 A.M, Russell responds to an e-mail that Villa sent regarding why checks were cut to Runner Media, a corporate entity that Wisconsin Department of Financial Institutions reflect has Russell as the registered agent. Runner Media was involved in the purchase of media time on behalf of political action committees. Russell said that "I screwed up." Villa sends an e-mail in response at 10:22 a.m. regarding the invoice related to Runner Media. On August 20, 2010, Russell was not working and was using a furlough day. (Exhibit 15)

29. In as much as Exhibits 1 through 15 establish a business and financial relationship between Hiller, Villa, and Russell in which Russell is tasked with political activities involving W.F.F. and P.A.F. during Russell's work hours, it is reasonable to believe that Villa and Hiller were involved in the Solicitation involving Public Officials and Employees (PTAC), and evidence related to those activities would be found in e-mail, correspondence and other documents located at the residence and office of Jim Villa as described in  $\P5(a)$ , as well as the residence of John Hiller as described in  $\P5(a)$ .

### C. MID AMERICAN CLEANING SERVICE.

30. As described above and in previous affidavits incorporated by reference, I know that Hiller was the Treasurer of the Friends of Scott Walker campaign during Governor Walker's 2010 campaign for Governor. Additionally, based upon documents recovered, I know that a letter was sent on August 6, 2008 to Edward Aprahamian by Daniel Morse thanking him for agreeing to serve on Walker's Gubernatorial Finance Committee. A description of the role of the finance committee is described in the affidavit of July 11, 2011, in ¶33 and above.

a. On July 31, 2009, Milwaukee County posted a Request for Proposal No. 998000 (hereafter RFP) in which bids were sought for housekeeping services for Milwaukee County. Records reflect that the proposals were due by August 24, 2009. After the proposals were received, a review process

occurred in which the proposals were evaluated and ranked that was completed at the end of September 2009.

b. Prior to the award of the contract related to the above RFP, John Hiller directed an e-mail on November 11, 2009 to County Executive Scott Walker and Deputy Chief of Staff Tim Russell relating to Mid American Building Services, who submitted a bid on RFP 998000, noting the number of buildings that Mid American Building Services in which the company was providing cleaning services to the city (of Milwaukee) (Exhibit 16) Tim Russell then forwards the information to the attention of Cindy Archer, Director of the Milwaukee County Department of Administrative Services (Exhibit 16, pg 2)

c. The proposal of MidAmerican Building Services was awarded on December 10, 2009. (Exhibit 17)

d. Bank records obtained from M and I Bank reflect a payment by Mid American Building Services to John Hiller (d.b.a. JM Hiller Consulting LLC) on December 17, 2009 for \$4,000. (Exhibit 18)

e. On December 10, 2009, Ed Aprahamian, owner of Mid American Building services, exchanged a series of e-mail's with John Hiller. (Aprahamian used the address of <u>webmaster@fichterservices.com</u> and Hiller used <u>johnhiller@hillerrealty.com</u> and <u>johnhiller@att.blackberry.net</u>. In the email, Aprahamian details for Hiller the hiring of county workers by MidAmerican. (Exhibit 19) An e-mail sent on December 11, 2009 reflects that Ed Aprahamian also used the e-mail of <u>eda@fichtservices.com</u>. (Exhibit 20)

f. On November 17, 2009, Corporation Counsel Attorney William Domina sends an e-mail to Amos Owens, a purchasing administrator for Milwaukee County, regarding restrictions related to the procurement process contained in Milwaukee County Ordinances. Attorney Domina opines that "the Code prohibits the disclosure of information related to procurement, it is not prohibited for your office to provide to policy makers in a confidential communication a range of bids, . . . the number of bidders; the position of the bidder recommended for selection..) (Exhibit 21)

g. In spite of the restriction on the disclosure of procurement information described in ¶36(f), on December 15, 2009 at 10:07 a.m., on the subject of housekeeping procurement, Cindy Archer sends an e-mail to Tim Russell indicating that she is being sent the information Russell requested. Archer indicates that the contract has not been awarded because DHSS has not processed the paperwork. (Exhibit 22 – top portion) With respect to Behavioral Health Services / Delinquency, Archer explains that it is two contracts to the same vendor. Archer concludes the e-mail indicating that she will send the other information when she receives it. (Exhibit 22 – bottom portion). At 11:12 a.m., Archer receives an e-mail from Amos Owens of the Milwaukee County Department of Administration with the BHD RFP. Archer immediately forwards the e-mail from her Milwaukee County e-mail to her private email at carcher1@wi.rr.com. (Exhibit 23)

On December 15, 2009, beginning at 11:10 a.m., Cindy Archer (using h. her private e-mail - carcher1@wi.rr.com) then forwards three separate documents related to Janitorial services with Milwaukee County to Tim Russell with a copy to Tom Nardelli. The first e-mail reflects that at the request of Tim Russell, Archer sends the "Janitorial Housekeeping Score Sheets" to Tim Russell with a copy to Tom Nardelli. At 11:11 a.m. Archer forwards the "DHHS Housekeeping Cost". At 11:15 a.m., Archer forwards the "BHD Janitorial Housekeeping RFP" (BHD - Behavioral Health /Delinguency) with a note that the RFP is "back on the website." (Exhibit 24) Russell then forwards the "DHHS Housekeeping Cost" and "BHD Janitorial Housekeeping RFP" to Brian Pierick at 11:23 and 11:22 a.m. respectively. (Exhibit 25). Brian Pierick is a roommate of Timothy Russell employed in a private law firm, and not a Milwaukee County employee. Based upon my review of e-mail and other documents obtained through the John Doe, Pierick is involved in "blogging" in support of Scott Walker, which may be the reason the information is provided to him...

i. Archer had received the information that included scoring sheets from Amos Owens from the Department of Administration in two e-mails sent on December 15, 2009 at 10:57 a.m. and 10:56 a.m. (See Exhibit 26) A

subsequent story in the Milwaukee Journal-Sentinel dated December 13, 2009 reflects MidAmerican Building Services the previous week was awarded a contract for cleaning the Milwaukee County Courthouse and nine other buildings effective January 18, 2010. The article notes that the County Executive (Scott Walker) used a standard procurement process for picking the companies rather than a professional service contract that would require the approval of the Milwaukee County Board of Supervisors. (Exhibit 27)

j. On December 17, 2009, a blog posting at the "ScottforGov" blog is made under the title "Walker and the Housekeeping Contract." In that posting the blogger presents information related to the Housekeeping contract, disclosing that Jon McAlpine, owner of Jani-King had scored 46.51 and ranked 7<sup>th</sup> in the bidding for the Milwaukee Courthouse (contract) while defending the awarding of the contract to Ed Aprahamian of Mid American Cleaning. (Exhibit 28) This information is contained in the scoring sheets that Archer received on December 15, 2009 (see Exhibit 26). I know that the domain for the "ScottforGov" was purchased by Tim Russell based upon a review of subpoenaed records, and that Brian Pierick and other associates of Pierick regularly posted to the above blog.

k. On March 3, 2011, a search warrant was executed at the residence of John Hiller and documents were selzed during the execution of a search warrant, including check stubs for checks payable to JM Hiller Consulting LLC. Three check stubs were located from MidAmerican Building Services made out to JM Hiller Consulting LLC; the first dated November 4, 2010 in the amount of \$1,000; the second dated January 3, 2011 in the amount of \$1,000; and a third dated February 11, 2011 in the amount of \$12,000.00. (Exhibit 29)

I. On January 21, 2010 Aprahamian sends a e-mail to Hiller, where Aprahamian discusses proprietary information with Hiller that "could be used by other firms to compete against MidAmerican." [sic] (Exhibit 30)

m. On July 26, 2010, Hiller sends an e-mail to Kelly Rindfleish (at <u>kmrindfleisch@gmail.com</u>) about getting the June invoice for MidAmerican

paid by Milwaukee County. Kelly Rindfleish worked in the office of the County Executive. (Exhibit 31)

n. Rindfleisch and Hiller continue to exchange e-mails related to the problems with the receipt of payments by Mid American Building Services and Milwaukee in e-mail communications between August 6 and 18, 2010. Rindfleisch indicates that she is "checking on it" and agrees to determine what the "lag" in payment is. (Exhibit 32).

o. Ed Aprahamian is listed as a <u>potential</u> contributor of \$500 in an October 21, 2009 e-mail from Phil Prange regarding the Walker for Governor campaign. Wisconsin Campaign contribution reporting records reflect Ed Aprahamian made contributions on December 31, 2008 and June 29, 2010, each in amount of \$1,000; also a \$2,000 contribution on April 30, 2005. (Exhibit 33)

Exhibits 16 to 33 establish potential violations of Wisconsin Stats. § 946.12 and 939.05 with the unauthorized disclosure of procurement information related to bidding on a contract involving Tim Russell, Cindy Archer and Brian Pierick.

### C. PHONE RECORDS RELATED TO MILWAUKEE COUNTY EXECUTIVE STAFF AND FRIENDS OF SCOTT WALKER

31. As described in the affidavit of Chief Investigator David Budde dated September 13, 2011, a review of e-mails, records, and testimony has established that members of the Friends of Scott Walker gubernatorial campaign committee tasked Milwaukee County Executive's office staff with political activity during the workday while those individuals were employed with Milwaukee County. Consequently records related to telephone records and e-mail communications involving the Friends of Scott Walker campaign office and employees, as well as Cindy Archer, Jim Villa, Tim Russell, Brian Pierick, Kelly Rindfleisch, Fran McLaughlin, Thomas Nardelli, Darlene Wink, Jon Myhre, Cheryl Berdan, Dorothy Moore, R.J. Johnson, Jill Bader, and Keith Gilkes are relevant to the Investigation, reflecting communication and contact between the above Individuals potentially related to political activity in violation of Wisconsin Stat. §§946.12, 11.36(2), 11.61, 939.30, and 939.05. Additionally, based upon the information described herein, telephone records and e-mail communications

will provide detail and evidence of contacts between John Hiller, Jim Villa, Scott Walker, Cindy Archer, Ed Aprahamian, Tim Russell, Phil Prange, relating to violations of Wis. Stats. §§946.12, 19.58, 19.59, 939.05 and 939.30. Based upon a review of records, documents and evidence obtained during the course of the John Doe investigation, the following individuals had the following phone numbers during the relevant timeframe described below, with electronic telecommunication service provided by the entities described below based upon information from fellow law enforcement sources. In some instances, phone records have already been subpoenaed with respect to the relevant timeframe, September 1, 2009 to December 31, 2011, and for this reason only records for those timeframes needed to complete the records are listed. Those records are:

### D. CONCLUSION

32. As detailed in the above, John Hiller - the campaign treasurer for the Friends of Scott Walker gubernatorial campaign fund, maintained contact directly with members of the Milwaukee County Executive office including Milwaukee County Executive Scott Walker, seeking contracts on behalf of "clients." Hiller is involved with Ed Aprahamian in securing the contract for Mid American Building Services in 2009; Ed Aprahamian is a member of the "Finance Committee" per the letter of August 6, 2008. John Hiller had a pecuniary interest with the payment of \$4,000 shortly after the contract was awarded. A second instance of direct contact with members of the Milwaukee County Executive's office is described in the Affidavit of July 11, 2011 involving the extension of the Reuss Plaza lease and response to RFP 6562. John Hiller had a pecuniary interest in a lease with the Boerke Company. At this same time, Scott Walker had a direct or indirect pecuniary interest in a contract with the Boerke Company and Mid American Building Services created as a result of Hiller's status as campaign treasurer and his involvement in the Mid American contract as well as the

lease extension and RFP on behalf of the owners of the Reuss Plaza. David Boerke was also a member of the "Finance Committee" - a committee involved with contributors to the Scott Walker for Governor campaign in amounts greater than \$2,500. Scott Walker also had a direct or indirect pecuniary interest in the contract as a result of campaign contributions from individuals from Ed Aprahamian/ Mid American Building Services, and The Boerke Company.

33. For all the reasons set forth in the foregoing paragraphs, I believe that probable cause exists that the offenses identified in ¶5 and ¶7 have been violated and that the courts of Milwaukee County have jurisdiction over these offenses. John Hiller was a resident of Milwaukee County during timeframe described above. Further, there is probable cause to believe that the entities identified in ¶5 are in possession of records, information and documents constituting evidence of said offenses. Accordingly, I request the following process issue.

34. I request that a <u>search warrant</u> be issued for Cindy Archer and the residence of **Cindy Archer** as described in ¶5(b), based upon observation of Cindy Archer at the residence on September 12, 2011, the movement of vehicles owned by Cindy Archer at the above residence during the week of September 9, 2011 consistent with that of her residence; City of Madison records that reflect Cindy Archer as the owner of the above residence; current Wisconsin Dept. of Transportation records reflecting the above location as her address per her license; and the present registration of vehicles owned by Archer at the above address; as the above may provide evidence related to violations of sections Wisconsin Statutes §§946.12, 19.58, 19.59, 939.30, and 939.05 the Wisconsin Statutes, viz., Solicitation to Commit Misconduct in Public Office, Misconduct in Public Office (PTAC) and Ethics Violations (PTAC).

35. Herein, I use the terms "records" "documents" and "information" to include all items of evidence in whatever form and by whatever means they may have been created or stored, including any form of computer or electronic storage (such as hard disks, jump drives, thumb drives, CDs, DVDs, external USB drives, 3.5" disks or other media that can store data); any handmade form (such as writing, drawing, painting); any mechanical form (such as printing or typing); and any photographic form (such as microfilm, microfiche, prints, slides, negatives, videotapes, motion pictures, photocopies).

36. I further request authorization for the inspection of the contents of all computers and electronic communication devices for the reasons stated in ¶1 to ¶40.

37. I respectfully request that the court issue a <u>search warrant</u> for the person of Jim Villa and the residence of **Jim Villa** and the office of **Jim Villa at CARW** as described in ¶5(a), based upon interviews and personal observation of personal items at the above location consistent with the above location as the residence of Jim Villa, as well as observations related to the personal vehicle of Jim Villa at the above location within the past 6 days, and City of West Allis records, that also establish the above residence in West Allis, Wisconsin as that of Villa; further the office of Jim Villa at the above location in Wauwatosa, Wisconsin based upon documents and records establishing the above location as the office of Jim Villa in Wauwatosa for Commercial Association of Realtors - Wisconsin (CARW) and again personal observations of the vehicle of Jim Villa at CARW; as the above may provide evidence relating to violations of sections Wisconsin Statutes §§946.12, 11.36, 11.61, 19.58 and 19.59, 939.30, and 939.05 the Wisconsin Statutes, viz., Solicitation to Commit Misconduct in Public Office, Misconduct in Public Office (PTAC), Ethics Violations (PTAC), and Solicitation involving Public Officials and Employees (PTAC).

38. I respectfully request that the court issue a <u>search warrant</u> for the person of John Hiller and the residence of John Hiller as described in ¶5(c), as said residence was the subject of a search warrant in March, 2011 and found to be his residence, and based upon present information, said location remains his residence; the above may provide evidence relating to violations of sections Wisconsin Statutes §§946.12, 11.36, 11.61, 19.58, 19.59, 939.30, and 939.05 the Wisconsin Statutes, viz., Solicitation to Commit Misconduct in Public Office, Misconduct in Public Office (PTAC), Ethics Violations (PTAC), and Solicitation involving Public Officials and Employees (PTAC). 39. With respect to ¶5(e), ¶5(f), ¶5(g), and ¶5(h), I request that a <u>search warrant</u> be issued to the following electronic communication service providers for the timeframes described herein for the documents identified below: to Google G-mail for Cindy Archer — <u>cyn.archer22@gmail.com</u>; G-mail account for John Hiller-johnhiller4@gmail.com, Yahoo e-mail for the account Brian Pierick at pierick.brian@att.net; to GoDaddy for the account of Jim Villa, (JV@jimvilla,com); to

Yahoo e-mail for the accounts of Ed Aprahamian at <u>lezk@yahoo.com</u> and Brian Pierick at pierick.brian@att.net; to Ntelos for the email accounts of Ed Aprahamian (eda@fichtservices.com; webmaster@fichtservices.com; with respect to all of the above accounts and service providers said search warrant is for the production of all communications stored in the account including all incoming and outgoing e-mail; subscriber names, user names, screen names or other identities associated with the account; mailing addresses, residential addresses, business addresses, other e-mail addresses, telephone numbers or other contact or identifying information for this account (in electronic or other form); billing records; information about length of service, types of services or related information; connection logs and records of user activity, and any information related to sent and received communications, including any "chat" or "instant messaging" or related information for said account, and other records identified in ¶5 above, as it may provide evidence related to violations of Wisconsin Statutes §§946,12, 19.58, 19.59, 939.30, and 939.05 the Wisconsin Statutes, viz., Solicitation to Commit Misconduct in Public Office, Misconduct in Public Office (PTAC), Ethics violations (PTAC), and Solicitation involving Public Officials and Employees (PTAC), contrary to Wisconsin Stats §§11.36(2), 11.61, and 939.05.

40. With respect to the above phone records identified in ¶5(i) and as described in ¶31, a subpoena for documents is requested with respect to the electronic telecommunication service providers identified above (**Sprint, United States Cellular, AT & T, Et al**.), as said records will provide evidence related to the offenses described in ¶7.

# Incoming custodial firm faces a stink

### Some county bathrooms won't be cleaned until 2010

Edward M. Aprahamian Jr. has a mess to clean up.

Aprahamian, the owner of a West Allis janitorial firm, inherits the job of cleaning the Milwaukee County courthouse complex and other buildings as the county privatizes its custodial staff. It's a move County Executive Scott Walker has long sought and the County Board resisted.

Walker won the privatization fight in the 2010 budget, as one of a number of measures used to help plug a large budget shortfall. The county last week awarded MidAmerican Building Services a \$1.2 million contract for cleaning the courthouse and nine other Milwaukee County buildings, picking it over about 10 other firms.

MidAmerican officially takes over Jan. 18 and will be paid \$97,793 a month, according to its contract with the county. The company also will get paid about \$50,000 to handle a reduced level of cleaning under a temporary contract covering the next month. County department heads have been warned that only large public bathrooms and hallways will be cleaned until MidAmerican gears up with a full-time crew for the county work.

County staff custodians were laid off as of Friday, though many began calling in sick once word filtered out two weeks ago that their jobs would end soon. Just four of about 20 custodians assigned to the courthouse complex showed up for work Friday, said Jack Takerian, the county's interim public works director.

With complaints about the custodial service already being made and supervisors continuing to question the janitorial outsourcing, Aprahamian will have his hands full.

Aprahamian, 49, the president and owner of MidAmerican and a partner in a political consulting firm, has a long history of political donations, most of them to Republicans, state and federal campaign records show.

He is a longtime supporter of Walker, including his most recent \$1,000 donation to the county executive and Republican candidate for governor that was made in late June, around the time Walker's administration laid plans for privatizing custodial services for 2010. Aprahamian also has donated to Gov. Jim Doyle and Milwaukee Mayor Tom Barrett, both Democrats. Barrett also is running for governor.

Aprahamian did not respond to phone and e-mail messages seeking comment about the county contract

and his donations.

Supervisors last week complained they were cut out of the process to select private firms to take over custodial services for the county, a move that resulted in about 90 workers being laid off. Walker used a standard procurement process for picking the companies rather than a professional service contract method, which would have required County Board approval.

Supervisor John Weishan Jr. called the move "an abuse of our procurement process." He has called for the board to attempt to assert authority to review the custodial services outsourcing contract. A county lawyer said, however, that Walker was within his authority to issue the custodial contracts as simple procurements without County Board input.

Supervisor Peggy West said it was unfair that the board was shut out of details about the custodial services outsourcing. She said poor quality cleaning of the county's Marcia P. Coggs Human Services Center, 1220 W. Vliet St., by another private service demonstrated the folly of outsourcing the task.

She called the Coggs Center "disgusting. It's gross, it's not sanitary," she said.

John Barrett, county clerk of courts, said courthouse cleaning already had suffered in the move toward privatization. Barrett said he'd been warned bathrooms used by 300 court workers won't be cleaned until mid-January.

"I think people deserve clean bathrooms," Barrett said.

#### **Donations not a factor**

County officials said the company was picked based on an objective review that included quality of work, work history and price.

"I did not have anything to do with it," Walker said in an e-mail reply to questions about the contract.

Aprahamian made \$3,000 in donations to Walker since 2005, including his recent \$1,000 gift.

Takerian, the county's interim public works director, said there was no political influence involved in the selection of MidAmerican.

Aprahamian's cleaning company has a 40-year history in Wisconsin, Illinois and Indiana and does \$5 million a year in business, according to MidAmerican's contract proposal to the county. MidAmerican also cleans three public works buildings for the city, for which it was paid \$269,000 last year. The firm will be paid about \$128,000 this year to clean the Milwaukee State Office Building downtown.

Records show Aprahamian gave Doyle \$5,000 in 2002, when Doyle first ran for governor, and \$2,000 in 2003. Aprahamian also gave Barrett \$2,000 in 2005 and \$1,000 in 2007.

MidAmerican has done work for the city since at least 1999.
