I'm Karla Jones, the Director of International and Federal Relations at ALEC and it is my pleasure to invite you to renew your membership with ALEC in order to participate in a special ALEC Academy to learn more about Alberta's oil sands and the proposed Keystone XL Pipeline.

The dates for the Academy are October 16, 2012-October 18, 2012, and at this point, we have a budget that will allow for ten legislator participants and have a couple of spots still remaining that we are offering on a first come first served basis. If you could let me know today, if I should reserve a spot for you, I'd be most appreciative. If you are still able to participate on the trip, please confirm this with me as soon as possible. We will also ultimately need confirmation that you have obtained approval from the applicable ethics committee about the trip.
