On September 8, 2011 Governor Mary Fallin announced the appointment of Patrice Douglas to the Corporation Commission. Commissioner Douglas took office on October 10, 2011.

Born in Oklahoma, Patrice is a long time Edmond resident. She attended Oklahoma Christian for her undergraduate degree, and went on the University of Oklahoma, where she obtained her law degree.

Patrice practiced law full-time for 13 years until she joined the family business. Working with her father in his company, ACP Sheet Metal, she faced first-hand the challenges of small business owners. During her five years at ACP, she served as its vice president and general counsel.

With her legal experience and love of small business, banking was a perfect fit. Patrice served as president of SpiritBank, and executive vice president of First Fidelity Bank. She was appointed to the Oklahoma Bankers Association Board of Directors in May, 2011.

In April 2009, Patrice was elected Mayor of Edmund, OK, a position she held for almost 3 years.

E. Scott Pruitt



Attorney General, Oklahoma

Attorney General E. Scott Pruitt was elected as the 17th Attorney General of the State of Oklahoma on November 2, 2010, becoming just the second Republican in the history of the states to hold the office. As Attorney General, he has shown a dedication to fighting corruption, protecting Oklahoma's vulnerable citizens, championing public safety measures to reduce violent crime, and advocating excellence in the administration of law and justice.

Before being elected Attorney General, Pruitt served Broken Arrow, Coweta, and Tulsa in the Oklahoma State Senate where he served for eight years, four of those as Assistant Republican Floor Leader. In the Senate he was a leading spokesman for workers' compensation reform, lawsuit reform, and great accountability for government spending.

He earned a bachelor's degree in communications and political science at Georgetown College before being accepted to the University of Tulsa College of Law. After working his way through law school and earning a Juris Doctorate, Pruitt ventured into private practice, specializing in constitutional and employment law.

As Vice-President, Keystone Pipeline Projects, Corey Goulet has overall accountability for the development and implementation of all phases of the Keystone projects including securing land and permits, engineering, procurement, construction, commissioning, start-up, and testing.

Prior to his current role, Mr. Goulet was Vice-President of the Facilities and Pipeline Projects department where he was responsible for leading the technical development and implementation of power plant, compression, metering, and pipeline projects in Canada and the United States.

Mr. Goulet has 27 years of energy infrastructure experience.
