5 this subsection that conflicts with a rule or policy of the senate or assembly or joint  
6 rule or policy of the legislature shall apply to a record of the legislative branch  
7 withheld in compliance with such rule or policy.

1     **AN ACT to repeal** 13.92 (1) (a) 3. and 13.92 (1) (c); **to amend** 13.92 (intro.) and  
2           13.92 (1) (e) 5.; and **to create** 19.35 (1) (m) of the statutes; **relating to:**  
3           legislative rule or policy exception to the public records law and confidentiality  
4           of drafting records.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

5           **SECTION 1.** 13.92 (intro.) of the statutes is amended to read:  
6           **13.92 Legislative reference bureau.** (intro.) There is created a bureau to  
7           be known as the "Legislative Reference Bureau," headed by the chief of legislative  
8           reference bureau. The legislative reference bureau shall be strictly nonpartisan and  
9           shall at all times observe the confidential nature of the reference or, drafting, and

1 research requests received by it, and all drafting files and other records relating to  
2 those requests shall remain confidential at all times.

3 **SECTION 2.** 13.92 (1) (a) 3. of the statutes is repealed.

4 **SECTION 3.** 13.92 (1) (c) of the statutes is repealed.

5 **SECTION 4.** 13.92 (1) (e) 5. of the statutes is amended to read:

6 13.92 (1) (e) 5. Microfilming, optical imaging or electronic formatting of  
7 reference materials ~~and legislative drafting records under par. (a) 1. and 3.~~

8 **SECTION 5.** 19.35 (1) (m) of the statutes is created to read:

9 19.35 (1) (m) No requirement of public inspection, copying, or disclosure under  
10 this subsection that conflicts with a rule or policy of the senate or assembly or joint  
11 ~~rule or policy of the legislature shall apply to a record of the legislative branch~~  
12 withheld in compliance with such rule or policy.

13 **SECTION 6. Initial applicability.**

14 (1) DRAFTING RECORDS. The treatment of section 13.92 (intro.) and (1) (a) 3., (c),  
15 and (e) 5. of the statutes first applies to a proposal introduced on the effective date  
16 of this subsection.
